

Privacy Policy

In this Privacy Policy:

“we”, “us” or “Wedderburn” means Wedderburn New Zealand Limited or any related Wedderburn company providing you with our goods or services;

“you” means you, the person acquiring our goods or services or visiting our website; and

“services” includes access to our website.

This statement applies to **Wedderburn**.

Uses

We use information about you to help us with our internal accounting and administration, and to endeavour to reduce the likelihood of fraud occurring. We use information to fulfill promotional obligations. We use information to measure the number of visitors to the different parts of our website.

We do NOT share, sell, trade or rent any personal information about you with anyone, other than as may be required by law, as needed by us to assist in managing our relationship with you or as consented to by you. Wedderburn may provide aggregate statistics about our customers and website trends, however, these statistics will not have any personal information which could identify you (unless for the reasons outlined above),

This Privacy Policy means that we may require proof of identity before we disclose any information to you.

The Internet is not a secure environment. If you send us information, including your email address, it is sent at your own risk.
